We've heard it time and time again; 2020 was a year like no other. The country not only faced the Covid-19 pandemic, which caused both a public health crisis and an economic crisis, but it also saw stark reminders of the social and environmental challenges demanding our long overdue, collective attention. This will surely be a year we look back on and remember as one of the most difficult in our lifetime. However, challenging times often have an innate ability to bring out the best in companies and people alike. I'm proud to report with absolute certainty that 2020 did in fact bring out the best in Bay State Savings Bank.


Thanks to our employees' agility, resilience, and innovation, our commitment to deliver exceptional customer service remained steadfast. From our participation in the U.S. Small Business Administration's Paycheck Protection Program (PPP), putting nearly \$30 million back into the hands that needed it most, to tailoring our services to meet the unique needs of each individual customer, Bay State rose to the occasion time and time again.

Financially, our Bank concluded 2020 in outstanding financial health. Assets were at \$469,314,000, net loans at \$401,904,000, net income at \$2,307,000 and capital ratio at 8.83%. Asset growth for the year was 7.2%, loan growth 1.4%, and deposits grew over 10.6%.

This year's Report highlights the strides forward we made despite having to redefine how we conducted business and communicated with customers. We hosted homebuyer seminars virtually and provided financial literacy assistance to the community through an online educational series, #FinanceFridays. We also recognized the uptick in cybercrimes and put considerable effort towards helping our customers stay safe, which included increasing the frequency of customer security updates, as well as launching Zelle, a convenient, secure way for our customers to send money using online and mobile banking.

Although 2020 was a year centered around social distancing, Bay State continued to remain an active contributor to the community. Some of this year's noteworthy donations include a \$10,000 donation to the Worcester Together Fund, a Central Mass Covid-19 relief fund; and a fundraiser in honor of our mascot Benjie's first birthday, benefitting NEADS service dogs in Princeton, MA, which raised over \$6,000. Other initiatives include partnering with the Bravehearts to provide youth with summer camp scholarships; partnering with local restaurant, Quinn's Irish Pub, to provide food for front line workers; and partnering with the YWCA of Central MA, supporting their efforts to eliminate racism.

The Bay State Savings Charitable Foundation also had an exceptional year in giving. The Foundation, established in 2003 to support non-profit organizations and programs that enhance the quality of life in our surrounding communities, distributed more than \$17,000 in grants in 2020. Since its establishment, the Foundation has distributed in excess of \$700,000.

As difficult as the last year has been, Bay State Savings Bank undoubtedly rose to each of the challenges presented and capitalized on every opportunity. I am most thankful to have gone through this year with our dedicated Board of Directors, Corporators, and my coworkers, and am looking forward to rising together, for the years ahead.
